We invite you to join us on **December 2nd, 2010** for this, our sixth annual Hall of Distinction award presentation. Prior honorees have included Leo Wells III (2009), Hal Barry (2008), Steve Selig (2007), Jim Borders (2006) and Jim Jacoby (2005). The Hall of Distinction is the highest honor given by REIAC and was conceived in 2005 to recognize the people and commercial real estate projects that have made the most dramatic impact on Metro Atlanta.

As you will hear on December 2nd, Egbert Perry's life and his impact on Atlanta create a remarkable story. Born on the island of Antigua, Mr. Perry came to the US to finish his last two years of high school in New York. He then attended University of Pennsylvania's Engineering School, where he received his Bachelors of Science and Masters of Science degrees in Civil Engineering. He also attended the University's Wharton Business School, where he received an MBA, with majors in Finance and Accounting. After a short stint in DC, he moved to Atlanta and entered the commercial real estate development and construction world.

In Atlanta, Mr. Perry introduced progressive ideas to urban living all over the city. One example is the replacement of the dilapidated and crime-ridden Techwood Homes project with Centennial Place, which today stands as a model in-town, mixed-income, mixed-use community that has inspired over 100 similar developments across the country, some of which have been implemented by Perry's firm.

Mr. Perry has chaired several major civic initiatives related to growth, economic development and housing and serves or has served on the Boards of Directors of Fannie Mae, the Federal Reserve Bank of Atlanta, and Atlanta Life Financial Group and the Boards of Trustees of the University of Pennsylvania, Children's Healthcare of Atlanta, and the Carter Center Board of Councilors, among others.

Our program format will feature an on-stage interview with Mr. Perry by Matt Valley, Editor in

Chief of National Real Estate Investor magazine. And, presenting the award will be Jim Borders, President of Novare Group and our 2006 Hall of Distinction recipient.

Each year, the REIAC/GSU Hall of Distinction award program is a heavily attended festivity that is open to the entire commercial real community, not just REIAC members. We hope you will join us for this fun and informative celebration.
